A Hate-Crime:

It is alleged to be a criminal offence if a person's acts or omissions are perceived by the alleged victim or any other person to be motivated by a hostility or prejudice based upon a person's race, religion, sexual orientation, or disability (or perceived so to be) and any such act or omission is alleged to be motivated by a hostility or prejudice against a person who is transgender or perceived so to be.

A theoretical example:-

The archbishop of C is a devout Christian and keen to carry on the works of Christ and bring Christ's enlightenment into this world. In the course of his conversion ovrks and sermons about the true God, he will appear prejudiced in favour of Christ against other faiths, including against Muslims when preaching in favour of Christianity.
